PETITION FOR REDRESS.

I humbly wish to submit my petition for redress as follows:-

- I was staying together with my husband and a quarell ensued between us. I therefore reported the matter to Katanga Police Station. That familities reported the matter to Katanga Police Station. That families of both parties intervened in the case but there was no amicable settlement.
- I therefore filed a suit against my husband at Jamikan Magistrate court. After going through the due process the Magistrate called me into his office and asked me to give him my trate called me into his office and asked me to give him my contact number which I did and I also took his number. He also demanded an amount of GHGS,000.00 but I told him I can not afford to pay that amount. Because I could not afford not afford to pay the GHGS,000.00 be asked me to meet him at Worswors. to pay the GHØ8,000.00 he asked me to meet him at Worswors.
- 3. When we met at Worawora he asked me whether I have gotten the money and I told him no. He then told me to allow him to sleep with me so that he will try the case in my favour. He then started fondling with my breast. On that day he slept with me at Worawora and from then we were communicating as somebody and her boyfriend.
- True to his word he tried the case in my favour and awarded a cost of GHØ28,000.00 to my husband.
- 5. That one week later he called me on phone to give him a loan and the next day I met him at Abotoase and gave him the GH#5,000.00 he asked for.
- 6. Later he came to pick me at Addonkwanta and took me to Kete Krachi where we spent the night at a hotel I do not know its name.
- 7. That on our way coming back to Addonkwanta we met a flock of cattle and he express the desire to rare some and I tol him that that is my father's work and I am taking care of the cattle. Due to that he gave me money to buy two cattle and four days later I went to buy another two cattle at Addonkwanta from a man by name Chomor, who took care of the cattle
- 8. That he also gave me GHØ2, 700,00 to make a ground nuts farm. By the grace of God the farm had a good yielding and he came to share it and gave me my part.

- We went to Kumasi and were in Kumasi when we had a message that the one taking that the one taking care of his four cattle has run away
- 10. Any time we go to Kumasi I stay with his sister so that any time he needs me he will come for me.
- 11. In May, 2022 he told me that he has done away with me when I asked him what I have tone before he is doing away with after destroying my marriage. He then demanded the four cows from me. I then told him how am I to search for the cattle but he told me any means to search for the cattle but he told me any means
- 12. One day I went to Addonkwanta Nauoano when he called me and asked me to come to Addonkwanta to give him his four cattle. Some hours later Mr. Alfred Ewabena Asiedu came to the village with a Police man and one Jallow and the Police man told me I am under arrest. Meanwhile Mr. Alfred Eyabana Asiedu Mr. Alfred Eyabana Asiedu Maited at Addonkwanta so Mr. Alfred Kwabena Asiedu waited at Addonkwanta so The Assembly man of the area followed us to Addonkwants where Mr. Alfred Kwabena Asiedu was waiting.
- 13. Mr. Alfred Kwabena Asiedu demanded that I accompany him to Katanga but Jallow told him he will lead him to where whereary cattle are. Mr. Alfred Kwabena Asiedu on arrival to wheremy cattle are asked my ful-eni caretaker of my cattle to point my cattles to him. But he did not do it He then asked Jallow to point my cattle to
- That on our way to Katanga the Police man's phone fell down and when he went to trace the phone, Mr. Alfred Kwabena Asiedu locked me and the Assemblyman.
- 15. That when we got to Katanga Police station, statement were taken from all of us. Before we reached the Police Station Mr. Alfred Kwabena Asiedu asked me that what is between us and I told him that I am his Girl friend.
- 16. Meanwhile he has gone to collect seven cattle and his must every thing belonging to him in my absence.
- Mr. Alfred Kwabena Asiedu has threatened that he will let me be reminded two weeks, be sentenced for 10 years and also 5 years old girl will be taken from my custody. 17.

I am therefore appealing to you to intervene on my behalf in this matter.
